# **COMPANY CIRCULAR**



## FURTHER COMPANY INFORMATION TO BE PROVIDED

- 1. The following must be provided to the Board's satisfaction:
  - a) An opening balance sheet prepared by a chartered accountant.
  - b) Certification from the chartered accountant that the company has a fully paid up capital of not less than \$50,000 for cash consideration.

Where a company has previously traded, the net assets of the company must be no less than \$50,000

- c) A list of names and addresses of the present shareholders and their share holdings.
- d) A copy of the most recent Particulars of Directors as filed with the Registrar of Companies.

[Note: The Board has designated that all directors must be eligible to apply for or obtain a licence (S. 17 (3) and S. 30)]

e) A copy of the Certificate of Incorporation of the company.

REMINDER: The annual renewal of a company licence requires a declaration that the financial situation of the company is not substantially different from the statement filed either with the application for the original licence, or at the time of the last renewal.

## REAL ESTATE AGENTS ACT 1976:- EFFECTIVE CONTROL

- 2. The principal officer of the company must be in effective control of the principal place of business of the company (S. 54 (1)). "Effective control" means that the principal officer must personally supervise, manage and control the real estate agency business at the principal place of business, and he/she must work actively and substantially at or from that place (S. 2).
- 3. There are situations where the principal officer holds no shares or not sufficient share to enable him/her to control the company. The Act does not prohibit such a share holding structure, but still places a clear obligation on the principal officer to maintain effective control of the real estate agency business. Evidence that the company, its shareholders and the principal officer recognise this obligation is normally provided to the Board by way of an employment agreement between the principal officer and the company, including an acknowledgement by the shareholders that effective control is vested in the principal officer.
- 4. **Be aware that** if a principal officer is found by the Board not to be in effective control of the real estate agency business, the company's licence may be cancelled and the business closed.
